





Global architecture & security

Architecture - Layers

- Dedicated User Apps: dedicated apps provide tailored experience for every tenant type: issuers, issuer agents, custodians, brokers, investors, settlement infrastructures
- Microservices Ecosystem: handle external systems integrations, reporting
 - Edge Ingress Services accept requests from UI and external systems. Handle authentication, encryption, RBAC
 - Business Logic Services process requests received by ingress services, delegate core business logic to blockchain smart contracts, implement additional business logic, prepare reports
 - Blockchain Abstraction Services offer a higher lever, business-oriented interface on top of the blockchain, abstracting away the technicalities of dealing with a particular blockchain
- Blockchain: distributed ledger representing the unique source of truth for LiquidShare and its partners
